Welcome to The Lounge! With membership comes a few responsibilities. Your participation in The Lounge constitutes your acceptance of (1) all of The Lounge Terms and Conditions listed in this document and any additional terms and conditions that WWCD or any of its sponsors may impose from time to time ("The Lounge Terms" or "The Lounge Rules"), (2) WWCD's Privacy Policy, (3) WWCD's Terms of Use, (4) WWCD's Contest Rules, and (5) WWCD's Terms of Sale (collectively, "Terms").

Thank you for reviewing these Lounge Terms that apply to The Lounge program ("Program"), a free, loyalty-rewards program offered by WWCD, Ltd. dba CD 92.9 FM ("we," "our," or "WWCD") to customers and listeners located in the United States. In order to ensure that all of our valued members are treated fairly, we have established the following Terms and Conditions so that all members who participate in the Program will understand how the Program operates.

These Lounge Terms are between you and WWCD. They govern our respective rights and obligations. These Lounge Terms incorporate by reference (1) WWCD's Privacy Policy, (2) WWCD's Terms of Use, (3) WWCD's Contest Rules, and (4) WWCD's Terms of Sale (collectively, "Terms"). Together, these Terms constitute the entire agreement between you and WWCD related to this Program.

In the event of any conflict between these Lounge Terms and any other Terms, these Lounge Terms control, except that if these Lounge Terms conflict with WWCD's Contest Rules, WWCD's Contest Rules control unless expressly stated otherwise.

By enrolling, and by continuing to use the Program, you accept these Terms. From time to time, we may make changes to these Terms or terminate the Program. If we make material changes or terminate the Program, we will notify you by e-mail and/or by posting the new terms on The Lounge website.

BY APPLYING FOR MEMBERSHIP IN THE PROGRAM, YOU AGREE TO BE BOUND BY THESE TERMS. NO PURCHASE IS NECESSARY TO BECOME A LOUNGE MEMBER. VOID WHERE PROHIBITED BY LAW.

Summary

• To participate in The Lounge, you must be 18 years of age or older and a resident of the United States and meet other eligibility requirements as outlined in these Terms.



- Your account user name and password are strictly confidential, and you may not share your account user name and password with anyone else.
- You must provide and maintain a valid email address and promptly update your account with any changes. You acknowledge that WWCD will communicate with you about program changes, rewards, and promotional materials via e-mail and The Lounge website.
- Lounge Points have no cash value, are nontransferable, and are valid only for redemption in The Lounge as further explained in these rules or in our Contest Rules.

Creating an Account

You will need to create an account to use all or part of the Program. You must complete the registration process by providing WWCD with current, complete, and accurate information, as prompted by the applicable registration form. Your user name and password are for your personal use only and should be kept strictly confidential. You understand that you are responsible for all use (including any unauthorized use) of your user name and password. Notify our Customer Service team immediately if your user name or password is lost or stolen or if you believe there has been unauthorized access to your account.



FURTHERMORE, YOU ARE ENTIRELY RESPONSIBLE FOR ANY AND ALL ACTIVITIES AND CONDUCT, WHETHER BY YOU OR ANYONE ELSE, THAT ARE CONDUCTED THROUGH YOUR ACCOUNT. You agree to notify WWCD immediately of any unauthorized use of your account or any other breach of security. Neither WWCD nor its licensors will be liable for any loss that you may incur as a result of someone else using your password or account, either with or without your knowledge. You may be held liable for any losses incurred by WWCD, its licensors, or another party due to someone else using your account or password.

WWCD may reclaim, or require you to change, your user name for any reason.

Lounge Points

Each new Member will receive 929 Lounge Points upon registering a valid account that complies with these Terms. Members may accrue additional Lounge Points by successfully completing specified Program Elements (such as entering Lounge Tips, surfing the web, watching videos, participating in Sounding Board surveys, or taking surveys) (singularly, "Element," and collectively, "Elements"). Lounge Point awards vary by Program Element. See specific Element for details. Program Elements are subject to change or termination without notice.

Lounge Points can be redeemed only within The Lounge. Lounge Points do not have any cash value (unless required by law) and can be redeemed only for Contest Entries, Redemptions, or any other Lounge offerings. Changes, Termination, and/or Removal From Program
